#### Rationale

This is an investment project through Churchill Real Estate SPC for loans collateralized by residential properties, land, etc. in the U.S. ("real estate collateralized loan"), and the instrument for the rating is the facility for issuing notes by Churchill Real Estate SPC. LTV based on the Master Repurchase Agreement and the portfolio have remained in the initially assumed level, and resilience related to redemption of the notes is maintained.
