Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

### Sumitomo Metal Mining Co., Ltd. (security code: 5713)

#### Rationale

- (1) Sumitomo Metal Mining Co., Ltd. (the "Company") engages in all processes from resource development to smelting/refining and the production of battery materials and advanced materials. Having gained experience and know-how in mine development, it now owns a number of resource interests for copper and gold. Production began at the Quebrada Blanca Phase 2 Project in June 2023 and the Cote Gold Development Project in March 2024. For nickel, it has strength in the HPAL (high pressure acid leach) technology to recover high-grade nickel from low-grade oxide ores and the MCLE (matte chlorine leaching electrowinning) method to produce high-purity nickel. In the materials business, it develops and produces battery materials for automobiles, as well as other products including crystal materials for communications devices and powder materials for electronics parts.
- (2) Business base is solid for all three segments it operates. With synergies created through collaboration among these segments, the Company has an earnings structure that ensures profits even when the external environment deteriorates, including market conditions for non-ferrous metals. Recently, it has been in the development and production start-up phase for new mine projects, thus incurring up-front expenses, but is likely to see profit contribution from these projects thanks to an increase in production volume going forward. In the materials business, although demand for advanced materials has been weak, leading to a business downturn, it is expected to expand in the medium run. Moreover, JCR assumes that profits will turn around with an increase in the production of battery materials and productivity improvement. On the financial front, the Company operates its businesses with focus on maintaining financial soundness to prepare for large-scale investment projects that require short-term decision-making. Based on the above, JCR affirmed the ratings on the Company and retained the Stable outlook.
- (3) Profit before tax for the fiscal year ending March 2025 (FY2024) is expected to stay almost flat from the previous year at 91 billion yen. Even though inventory valuation will deteriorate, this will likely be covered largely by factors like improvement in the profitability of new mine projects. The profit is expected to rise gradually from FY2025 onwards as the resources and materials businesses turn around. That said, given the possibility that properties and materials required for battery materials will change with changes in customers' needs and technological innovation, JCR will keep an eye on future developments.
- (4) The ratio of equity attributable to owners of parent to total assets at the end of FY2023 was 58.9%, as opposed to 60.3% a year before. Although it deteriorated slightly because of an increase in interest-bearing debt due to aggressive capital investments, it still is at a good level. Large cash outflow for capital investments is expected for FY2024, too, but investment amount will decrease after that with the completion of new mine development, curbing the increase in interest-bearing debt. Given also that equity attributable to owners of parent will likely improve with profit accumulation, the Company's financial position is not likely to deteriorate.

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

#### A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

#### B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

#### C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Related Parties' Status and Stance of Support/ Assistance for the Issuer The credit rating is subject to alteration if there is a change in the issuer's parent company or

subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

#### E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.
