Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

MORI HILLS REIT INVESTMENT CORPORATION

(security code: 3234)

<Affirmation>

Long-term Issuer Rating: AA

Rationale

- (1) MORI HILLS REIT INVESTMENT CORPORATION ("MHR") is a diversified J-REIT, which is sponsored by MORI BUILDING Co., Ltd. (the "Sponsor"). Its asset manager (the "AM") is Mori Building Investment Management Co., Ltd. The current portfolio consists of following 11 properties: 10 properties with a certain level of superiority in terms of location, scale, specification, etc. (defined as Premium Properties by MHR); and Roppongi View Tower, which does not fall under the Premium Properties. The asset size based on the total acquisition price reaches 404.6 billion yen.
- (2) A stable track record overall can be confirmed for MHR's leasing business operations based on the strong cooperative relationship with the Sponsor group. With a portfolio consisting of favorably located, Premium Properties in central Tokyo, MHR shows achievements, such as an average NOI yield of 3.5% in the fiscal period ended January 2024, and an occupancy rate of 99.2% at the end of April 2024. Occupancy rates and rents were somewhat weak for part of pass-through type master lease properties (office buildings), for which fixed-rent master leases by the Sponsor are not set, but they are now turning to improve. In addition, given the support of fixed-rent master leases by the Sponsor (percentage in the total monthly rents: about 68%), MHR is assumed to maintain stable portfolio cash flow. Moreover, in light of the state of leverage control, etc., the financial soundness has been kept. Based on the above, JCR has affirmed the ratings on MHR with Stable outlook.
- (3) While planning to dispose the beneficial interests of Laforet Harajuku (limited proprietary right of land) in July and November 2024 (7% quasi-co ownership for each time), MHR is expected to continue to acquire properties going forward by leveraging the Sponsor's property pipeline with first refusal rights for external growth. JCR hence is paying attention to whether MHR will be able to advance the external growth while firmly maintaining the investment criteria held at the time of acquisition. In terms of internal growth, although there were large contract cancellations for some properties, they are promptly being backfilled. JCR will continue to follow up on its response to aging properties by using CAPEX, etc. (the average age of the portfolio at end-January 2024: 22.2 years), among others.
- (4) MHR's total assets-based book-value LTV stood at 46.1% at end-January 2024, kept controlled in the mid-40% level based on the AM's policy. At end-January 2024, unrealized gains on the portfolio, which serve as a financial buffer, amounted to 105.3 billion yen (unrealized gains ratio: 27.1%). There is no particular concern in terms of financing, given track records shown, such as maintaining a lender formation mainly comprised of major banks, diversified financing methods through issuing investment corporation bonds (green bonds) on the back of efforts for sustainability initiatives, average remaining years of debts kept longer than 4.0 years (4.0 years at end-January 2024), and staggered due dates.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a J-REIT might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions) including certainty of refinancing.



- D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

 The likelihood of debt payment is affected one way or the other by the issuer's related parties such as sponsor, asset manager, guarantor, and the government of the issuer's business domicile, etc. by their own conditions and/ or position of support/ assistance for the issuer.
- E) Order of Seniority in Debt Payment

 The likelihood of debt payment can be different between given debts of the same issuer. The

A) Portfolios

The credit rating is subject to alteration if there is improvement or deterioration of quality, competitive strength and diversification in the issuer's portfolios, since its revenue, etc. may improve or deteriorate by the change in its investment strategies, tenants' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the portfolios is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's sponsor or asset manager, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its portfolios, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

F) Rise and Fall in General Economy and Markets

The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's sponsor or asset manager, guarantor or other providers of credit enhancement, the government of the issuer's business domicile or other related parties' status and stance of support/ assistance for the issuer. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if there is a major change on the part of related parties, such as replacement, disappearance, some drastic improvement/ deterioration of financial grounds/ balances, etc.
