Rationale

- (1) AEON Financial Service Co., Ltd. (“AFS”), a consolidated subsidiary of AEON Co., Ltd. (“AEON”), assumes the comprehensive financial business of the AEON Group (the “Group”). It operates financial businesses including credit card, installment sales finance, banking, e-money and insurance in Japan and in the China, Mekong and Malay areas. Given the degree of AEON’s involvement in AFS and AFS’s managerial importance in the Group, JCR considers AFS’s long-term issuer rating to be at the same level as the Group’s creditworthiness, which is deemed to be equivalent to the rating of A. JCR also positively evaluates the solid business bases at home and abroad and sound financial base for AFS’s stand-alone creditworthiness.
- (2) The degree of AEON’s involvement is reasonably high. While AFS has a certain level of managerial independence partly because of the listing of its shares, AEON holds 49% voting rights in AFS and dispatches multiple directors to the latter, which, together with other factors, indicate their strong unity in terms of business administration. JCR views the degree of AFS’s managerial importance in the Group to be extremely high. AFS is strategically and functionally indispensable as it plays the role of providing financial services and retaining customers in the Group.
- (3) AFS boasts a strong position and competitiveness in the domestic credit card and other markets. Domestically, it has industry-leading credit card membership and a certain level of a customer base in the banking business as well, on the strength of its ability to utilize the Group’s management resources. As regards the business improvement order AEON Bank, Ltd. (“ABK”) received in December 2024, efforts to strengthen the management structure based on the improvement plan are progressing without delay, and no particular impact on the customer base has been observed. AFS is focusing on the expansion of high-yield receivables, including installment payments, with an aim to improve profitability, thereby gradually increasing the outstanding balance. Having revised the business portfolio by, for instance, divesting AEON Allianz Life Insurance Co., Ltd., it is also reallocating resources to the payment and lending businesses. Overseas, too, it enjoys a strong position as a non-bank in each area with a long operating history. Aiming to expand business domains, it has made a company providing personal loans in Vietnam into a consolidated subsidiary and launched a digital bank in Malaysia to broaden its customer base.
- (4) Earnings capacity is highly stable. Ordinary income firmly stays at a certain level thanks to business diversification, expansion into new regions and growing operating receivables for major products at home and abroad. In domestic operations, not only credit card revenue is expanding, but also net interest income is growing with interest rate hikes for ABK. In overseas operations, operating revenue remains steady across all areas, absorbing bad debt-related expenses and driving profit growth. Profit levels are recovering but are still below the pre-COVID levels, and factors like a temporary increase in expenses due to the introduction of a new credit system drag down profits. That said, given the accumulation of higher-yielding bonds, growth in financial income with interest rate hikes, productivity improvement initiatives through business restructuring and so forth, JCR assumes that AFS can secure a certain level of profits over the medium term.
- (5) Assets remain sound. Non-performing loans ratio is kept low for domestic credit card and housing loans receivables, which account for a large part of operating assets. As for bad debt-related expenses, those associated with credit card fraud grew sharply in the fiscal year ended February 2025, but this increase has subsided. Non-performing loans ratio is leveling off in the China and Mekong areas thanks in part to stricter credit screening. It rose slightly in the Malay area because of the expansion of operating assets. In any event, bad debt-related expenses relative to operating assets stay within a certain range in all areas.

(6) Capital adequacy is comparable to the rating. JCR-adjusted capital adequacy ratio remains at a decent level, and AFS has sufficient capital adequacy relative to risks. There are no particular concerns about liquidity. In terms of indirect financing, AFS has stable business relations with many financial institutions and has sufficient credit lines. It also has direct financing methods such as corporate bonds and the securitization of receivables.

- The credit rating methodology assumes, in principle, to be applied to assess the likelihood of a given debt payment in light of its issuer's condition and business environment, etc. in the relevant future. There is certain limitation, however, in the time horizon that the rating foresees.
- The credit rating methodology assumes, in principle, that the factors posted in the below are particularly important for such likelihood to be determined, and that the rating determination is made by evaluating each of them not only quantitatively but also employing qualitative analyses.

A) Business Bases

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

E) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's parent company or subsidiaries, guarantor or other providers of credit enhancement, the government of the issuer's business domicile or other related parties' status and stance of support/ assistance for the issuer. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if there is a major change on the part of related parties, such as replacement, disappearance, some drastic improvement/ deterioration of financial grounds/ balances, etc.
