Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

Mitsubishi Chemical Group Corporation (security code: 4188)

<Affirmation>

Long-term Issuer Rating: A+

Rationale

- (1) Mitsubishi Chemical Group Corporation (the "Company") is the holding company of Japan's largest diversified chemical group, Mitsubishi Chemical Group (the "Group"). The Group operates five segments: Specialty Materials, MMA & Derivatives and Basic Materials & Polymers (collectively, the "Chemicals Business"); Industrial Gases; and Pharma. It offers a large number of highly competitive products, including various types of high-performance materials, as well as MMA with the world's top share. The NIPPON SANSO HOLDINGS Group in the Industrial Gasses segment ranks fourth in the global market, while Mitsubishi Tanabe Pharma Corporation ("Mitsubishi Tanabe Pharma") in Pharma enjoys its position as a leading supplier of ethical pharmaceuticals in Japan. In light of such factors as the status of the holding company's governance, JCR reflects the creditworthiness of the Group as a whole in the Company's ratings.
- (2) Good business bases remain unchanged. The Industrial Gases and Pharma segments steadily secure profits thanks to their strong presence in the respective industries, contribution from growth driver products, etc., thus supporting group-wide performance in recent years. The Chemicals Business on the other hand, despite its strength in having diverse technological platforms, is seeing some businesses become unprofitable due in part to the deterioration of the business environment, leaving room for improving profitability. That said, under the new management structure from the current fiscal year, the Company intends to step up its efforts to strictly conduct business selection, implement appropriate pricing policies and streamline operations, which would help curb earnings volatility and boost profit growth over the medium term. Financial structure is improving steadily, and the Company will probably be able to remain in this direction for the time being. Based on the above, JCR affirmed the ratings on the Company and retained the Stable outlook. On a separate note, the Company has recently changed its policy concerning the petrochemicals and carbon products businesses to pressing ahead with collaboration and structural reforms within the Group instead of carving them out, which however will not affect the ratings.
- (3) The Company forecasts core operating income for the fiscal year ending March 2025 (FY2024) at 290 billion yen, up 39.9% from the previous year. Either profit growth or profitability improvement is expected for all segments. Robust performance as in the previous year is anticipated for Industrial Gases with strict price management and for Pharma with growth in the sale of Radicava, an oral agent for treating ALS, in North America and so forth. Moreover, recovery in demand for mainstay products in Specialty Materials and a rise in market prices of MMA monomers in MMA & Derivatives, along with other factors, are expected to help boost overall results. Even though Basic Materials & Polymers continues to suffer somewhat large losses in FY2024 as well, profitability will probably improve in FY2025 with a reduction in carbon production capacity.
- (4) While interest-bearing debt remains high at over 2 trillion yen, the Company is working to expand capital with steady profit accumulation. Net D/E ratio as of the end of the second quarter of FY2024 was 1.1x, improving from 1.8x at the end of FY2019 when it rose due to the consolidation of Mitsubishi Tanabe Pharma. As it stands, the Company has a reasonable level of risk tolerance against fluctuations in business performance and investment expenditures as equity attributable to owners of the parent amounts to as much as 1.7 trillion yen. It will make growth investments, mainly in priority business areas where social issues are addressed, also under the new medium-term management plan for FY2025 through FY2029 but strictly maintains its policy to improve the soundness of the financial base, as indicated by the target net D/E ratio set at 0.8x or less.

 - The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.
- C) Liquidity Positions
 - The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).



- D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

 The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. by their own conditions and/ or position of support/ assistance for the issuer.

Explanation or Measure of the Potential Volatility of the Credit Rating as Required by Paragraph (a)(1)(ii)(K) of Rule 17g-7

A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

G) Various Events

The credit rating is subject to alteration on occurrence of various events, such as change in the issuer's major shareholders, M&A and other organizational change, accident, violation of the law, litigation, legal/ regulatory change, natural disaster, etc., which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's business bases, financial grounds, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's parent company or subsidiaries, guarantor or other providers of credit enhancement, the government of the issuer's business domicile or other related parties' status and stance of support/ assistance for the issuer.
