Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

AEON Financial Service Co., Ltd. (security code: 8570)

<Affirmation>

Long-term Issuer Rating: A

Rationale

- (1) AEON Financial Service Co., Ltd. ("AFS"), a consolidated subsidiary of AEON Co., Ltd. ("AEON"), is responsible for the comprehensive financial business of AEON Group (the "Group"). AFS operates financial businesses such as credit cards, installment sales finance, banking, e-money and insurance in Japan and overseas, mainly in Asia. Based on the degree of control/involvement by AEON and managerial importance for AEON, AFS's long-term issuer rating is equivalent to AEON's group creditworthiness of "A." Also, regarding AFS's stand-alone creditworthiness, JCR positively evaluates the solid business base at home and abroad, and the sound financial base.
- (2) On the degree of control/involvement by AEON, while AFS has a certain degree of managerial independence as its shares are listed on the stock market, AEON holds 49% of the voting rights, dispatches several directors, indicating a high level of unity in managerial control. On the degree of managerial importance of AEON, AFS has a high degree of strategic/functional importance as it plays the role of providing financial services and retaining customers in the Group.
- (3) AFS has a strong market position and high competitiveness, including domestic credit cards. In Japan with its strength of being able to utilize the Group's management resources, the credit card business boasts an industry-leading cardholder base, and the bank business also has a certain size of customer base. Overseas, AFS has a long history of operating business, having built a high position as a non-bank in the each of the Greater China, Mekong and Malay areas. Through business selection and concentration, AFS is using managerial resources with a focus on the core domestic payment business and the growing overseas business. In the domestic payment business, AFS is raising the convenience of payment functions and strengthening its competitiveness by consolidating the Group's e-money issuing business and integrating it with an app. AFS is also expanding its cardholder base through collaboration and synergy realization with group companies. In the overseas business, AFS is working to open a digital bank in Malaysia and expand its business fields in Vietnam. Meanwhile, there are impact of credit card fraud, and AEON Bank, Ltd. received an order to improve its business practices due to inappropriate business operations related to Anti-Money Laundering / Countering the Financing of Terrorism ("AML/CFT"). Because measures have been taken for both AML/CFT, the customer base is unlikely to be impaired, in JCR's view. JCR will follow up on the progress of the measures and their impact on the customer base.
- (4) The businesses and geographical areas are becoming more diverse, and earnings are highly stable. AFS has increased its transaction volume and the balance of operating receivables for major products both domestically and overseas, firmly maintaining a level of ordinary profit. An increase in bad debt-related expenses is pushing down profit, but in Japan, the balance of operating receivables such as cashing, which decreased due to the COVID-19 pandemic, is recovering. Overseas, in each area, operating revenue has been strong, and profit has increased when excluding upfront expenses for digital banking. In addition to being able to expect higher financial revenue with interest rate hikes, AFS is also striving to improve productivity and efficiency by reviewing its business portfolio, etc. JCR will be paying close attention to whether it can recover its earning capacity.
- (5) The soundness of assets is maintained. With regard to domestic credit card and housing loans receivables, which account for a large portion of operating assets, the non-performing loan ratios remain stable at low levels. Bad debt-related expenses have temporarily increased due to credit card fraud, but the increase in expenses will likely subside as responses are progressing. Regarding overseas operating assets, the non-performing loan ratios in the Greater China area is rising, but the amount of non-performing loans in the Mekong area is beginning to peak. Bad debt-related expenses



- as a percentage of operating assets are within a certain range in each area, and JCR will watch whether the expenses can be kept controlled going forward.
- (6) Capital adequacy is comparable to the rating. The JCR-adjusted capital adequacy ratio remains at an acceptable level, and AFS has sufficient capital adequacy relative to risks. There are no particular concerns regarding liquidity. For indirect financing, AFS has stable business relations with many financial institutions and has sufficient credit lines. It also has a variety of direct financing methods such as corporate bonds and the securitization of receivables.

A) Business Bases

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

- B) Financial Grounds and Asset Quality
 - The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.
- C) Liquidity Positions
 - The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).



- D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

 The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. by their own conditions and/ or position of support/ assistance for the issuer.
- E) Order of Seniority in Debt Payment

 The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

Explanation or Measure of the Potential Volatility of the Credit Rating as Required by Paragraph (a)(1)(ii)(K) of Rule 17g-7

A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

G) Various Events

The credit rating is subject to alteration on occurrence of various events, such as change in the issuer's major shareholders, M&A and other organizational change, accident, violation of the law, litigation, legal/ regulatory change, natural disaster, etc., which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's business bases, financial grounds, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.

C) Liquidity Risks

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's liquidity positions. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the issuer's parent company or subsidiaries, guarantor or other providers of credit enhancement, the government of the issuer's business domicile or other related parties' status and stance of support/ assistance for the issuer. The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if there is a major change on the part of related parties, such as replacement, disappearance, some drastic improvement/ deterioration of financial grounds/ balances, etc.

E) Rise and Fall in General Economy and Markets

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the prospects of general economy and markets. JCR expects the change should be most likely by a notch but could be as much as a few notches, should the economy or the markets change so greatly.
