Rationale

- (1) SUMITOMO CHEMICAL COMPANY, LIMITED (the "Company") is a major diversified chemical company having advantages in specialty areas such as high-performance materials and crop protection chemicals. For the fiscal year ended March 2024 (FY2023), it reported a largest-ever net loss affected by sluggish performance of the Pharmaceuticals and Essential Chemicals & Plastics. In response to this, it is pushing forward drastic structural reforms comprised by revival strategies for the two businesses in a slump and growth strategies mainly for the Crop Sciences and ICT-related businesses in addition to the short-term intensive performance improvement measures aiming to generate approximately 600 billion yen of cash. In order to respond to new growth models, the Company has reorganized the business domains by linking them to the four social issues of food, ICT, healthcare and environment recently.
- (2) Feasibility of performance recovery is rising and downside risk is also being suppressed. Earnings are improving by implementing thorough rationalization and sales expansion of three core products in the North America in the Pharmaceuticals. In the Essential Chemicals & Plastics, the reconstruction plan for underperforming Rabigh Refining and Petrochemical Company ("Petro Rabigh") was finalized, and it was decided that the Company's ownership ratio would be substantially reduced going forward. On the other hand, competitiveness of the major products in the Health & Crop Sciences, IT-related Chemicals, Energy & Functional Materials is still maintained, and steady earning capacity of these business segments remains unchanged. Adverse effects from the performance deterioration for FY2023 also arouse on the financial side, but the financial structure will probably improve from the end of FY2024 because of positive outcome of the short-term intensive performance improvement measures and others. Based on the above, JCR have changed the rating outlook from Negative to Stable, concluding that downward pressure on the ratings was eased.
- (3) For FY2024, the Company projects a core operating income of 100 billion yen as opposed to 149 billion yen in the red for FY2023. The Pharmaceuticals plans to return to profitability by the structural reform effects. The Essential Chemicals will continue to underperform, but the loss is expected to shrink from the previous fiscal year. Although the results somewhat differ from business to business, performance is now picking up smoothly as shown that core business income was in the black for the first quarter of FY2024, for the first time in six quarterly periods. The short-term intensive performance improvement measures also seem to be in progress in line with the plan, and JCR believes that probability of achieving the full-year forecast of the core operating income is high. In relation to the debt waiver included in the structural reform plan of Petro Rabigh, a pre-tax loss of approximately 27 billion yen is expected to be recorded.
- (4) At the end of FY2023, net DER (based on equity capital, considering equity content of subordinated bonds; the same applies hereinafter) was 1.1x, showing substantial deterioration against that at the end of FY2021 (0.64x) when the financial structure improved the most lately. Although interest-bearing debt (without considering the equity content of subordinated bonds) was at a high level, standing at 1,600 billion yen at the end of FY2023, the Company intends to reduce it to 1,300 billion yen at the end of FY2024 by securing source of repayment through business reconstruction and careful selection of investments. At the end of FY2023, equity attributable to owners of parent (without considering equity content of subordinated bonds) was in the middle of 900 billion yen range; considerable financial resilience can still be recognized. Given that the initiatives in the structural

reforms are making progress and other factors, JCR views that it is unlikely that financial risk will rise from the present level.

A) Business Bases

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. - by their own conditions and/ or position of support/ assistance for the issuer.

E) Order of Seniority in Debt Payment

The likelihood of debt payment can be different between given debts of the same issuer. The likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment which is determined by design as financial product or by laws, etc.

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

The resultant change of the credit rating is most likely by a notch, as JCR speculates, but possibly as much as a few notches if the development is rapid in improvement or deterioration of the issuer's liquidity positions on some drastic change in its financial management policy or relations with fund procurement sources, etc.

D) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating herewith presented could be changed if and when the assumptions made at the time of its determination turn out to be inaccurate with regard to the order of seniority in repayment of interests and principal. JCR assumes the resultant change of the credit rating is most likely by a notch. The change could be as much as a few notches if the issuer's financial structure differs so much and thereby the balance between debts shifted so greatly. Rating change is also possible in case of the financial products for which non-payment of interest/ principal is contractually permissible, if and when the assumptions made at the time of its determination turns out to be inaccurate. The change of the credit rating is assumed to be by a notch but often as much as a few notches.

F) Rise and Fall in General Economy and Markets
