Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

NARITA INTERNATIONAL AIRPORT CORPORATION (security code: -)

Rationale

- (1) NARITA INTERNATIONAL AIRPORT CORPORATION ("NAA") is a special corporation wholly owned by the central government and is responsible for the management and operation of runways, passenger terminals and other facilities of Narita International Airport ("Narita"). Narita is Japan's leading international hub airport and functions as critical social infrastructure underpinning Japanese economy. Strengthening its functions to absorb aviation demand in the Tokyo metropolitan area, which is expected to grow in the medium to long run, is defined as a key policy of Japan, and the project to extend the existing runways and develop additional ones is underway. The Advisory Committee, which discusses the future plan for Narita, has compiled new measures to strengthen the airport function setting development of a centralized single terminal and new cargo area as the main focus. The project for carrying out these measures to strengthen the functions will be intended to go in full swing toward 2030s following the completion of runway developments. The initiatives to raise the international competitiveness of Narita is scheduled to be progressed over the long-term.
- (2) The ratings strongly reflect the central government's clear supportive stance underpinned by the political significance of Narita and also considering the fact that NAA maintaining certain financial soundness. For the purpose of promoting the runway development project consistently, the central government has been providing NAA with support for fundraising, and it budgeted additional fiscal investment and loans in light of increased project costs in the fiscal year ended March 2025 (FY2024). JCR views that the feasibility of the government providing NAA with tangible and intangible support will be high so that no obstacles arise in operating the airport in the future as well. Execution of the new airport functional enhancement measures requires a huge amount of money and a large-scale upfront investment is expected. The key factor drawing attention will be whether the government's financial involvement in NAA will become stronger.
- (3) On the back of an increase in visitors to Japan from Asian countries centering on Korea, the number of foreign tourists reached a new high for FY2024. While outbound travel has been weak due in part to the global inflation, recovery in the number of air travelers will appear to continue for the time being in light of the clear return of Chinese tourists at the moment. In the situation where issues, such as shortages of ground staff and supply of aviation fuel still remain, JCR will keep an eye on whether NAA will be able to capture the growing demand of international passenger flight without fail, and also changes in demand of international cargo transportation caused by the U.S. tariff policy and the impact on international cargo flights.
- (4) For the first half of FY2024, operating revenue was the highest ever on the basis of the first half, but operating profit has not yet recover to a pre-COVID level attributable to continuing deficit reported in the airport operation business caused by soaring energy prices and others. On the other hand, the retail business increased profits 70% from a year before. Sales of merchandise and restaurants have been strong due to an increase in the inbound visitors. The retail business will appear to maintain an uptrend for profits for the foreseeable future; thus JCR believe that NAA will probably be able to secure a certain amount of profits through comfortably absorbing deficits incurred by the airport operation business. Equity ratio as at the end of September 2024 improved from a year before to 20.5%, but financial structure is expected to deteriorate again because a fiscal investment and loan in the amount of slightly exceeding 150 billion yen was made in FY2024. That said, this was the funding extended by the government as a financial resource for the project costs with low interest rate in light of the significance of the runway development project for the political perspective. JCR views that this will contribute to financial stability of NAA because a burden of interest payment is largely held down compared to that from the private sector, and also the period until repayment begins is long.

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

D) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).

A) Legal Protection and Support Provided by the Government

The credit rating is subject to alteration if there is a change in the issuer's legal support by the government, personnel or capital relationship with the government, importance in the government's policy, credit enhancement and other forms of the government's supporting policy, framework and the strength thereof. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.

B) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

C) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased.
