Japan Credit Rating Agency, Ltd. (JCR) announces the following credit rating.

### **Development Bank of Japan Inc.** (security code: -)

#### Rationale

- (1) Development Bank of Japan Inc. ("DBJ") is the government's wholly owned special company. It supplies risk money under the GRIT Strategy that focuses on, among others, the realization of a green society and construction of a stronger regional, social and industrial infrastructure. The issuer rating reflects DBJ's high feasibility to receive government's support based on the special act as an agency, in which the government will continue to be involved for a certain period of time. JCR also considers DBJ's reasonably high standalone creditworthiness created by the solid business foundation established through working with large corporations and local public bodies, favorable asset quality and capital base.
- (2) DBJ is important because of its highly significant purpose of existence. It is legally obliged to perform Crisis Response and Specific Investment Operations, and the Japanese government's additional capital injection into DBJ and holding of DBJ shares are stipulated for such operations. Under the situation where the government defines strengthening supply chains and expanding investments in the fields such as GX/DX and startups as key policies toward economic growth, DBJ is supplying risk money mainly through the Specific Investment Operation primarily to these fields at the same time of encouraging the private sector to provide funds. DBJ plays the leading role in such initiatives. Following the cabinet decision made in November 2024, additional fiscal investment and loan was budgeted for DBJ to supply fund for capital investment to local industry business operators, and also to facilitate fund supply to startups primarily in AI, drug discovery and aerospace field, which the government positions as growth and core industries. Considering the statutory ties with the government and political significance, JCR views that DBJ's strong public nature will be maintained for a considerable period of time.
- (3) DBJ's consolidated core net business income has been maintained at a relatively high level. For the first half of the fiscal year ending March 2025 (FY2024), it decreased 40% from a year before due to an increase in funding cost, and elimination of gains on sales of shares related to some investees recorded in the previous period, but it is not particularly low compared to that in the past years. As for lending, DBJ has countered the decrease in interest income caused by progress of repayment of the loans for Crisis Response Operation through accumulating highly profitable loans such as structured finance and mezzanine loans. As for investments, DBJ is increasing stable earnings through expanding income-type investments such as mezzanine financing, investment in real estate and infrastructure-related businesses. Given these factors, JCR views that DBJ will be able to ensure a certain amount of net income absorbing credit costs and impairment losses by earnings related to lending and fees and commissions where profit/loss associated with investment decreases.
- (4) Asset quality is favorable. DBJ has many businesses with large blue-chip corporations and non-performing loans ratio under the Financial Reconstruction Act is low, standing at less than 1% as at the end of September 2024. However, quite a large part of investments and loans are for the sectors that tend to be affected by changes in the environment, including credit extension to large projects, and investments in equities and funds, making profits more volatile. Therefore, reserves/write-offs associated with investment and loan is at risk that it may largely increase from the plan due to factors of individual companies. Common Equity Tier 1 capital ratio on a sonsolidation basis is high, standing at around 18% at the end of September 2024, through profit accumulation and the government's investment. Having a large number of assets with high risk weights, risk assets are large relative to the total assets, but risk associated with investments and loans are appropriately controlled against the capital, which the amount is sufficient.

#### A) Business Bases

The likelihood of a given debt payment is highly conditional to its issuer's business bases - how they can be maintained/ expanded into the future and thereby secure earnings and cash flows in adequacy and in a sustainable way.

#### B) Financial Grounds and Asset Quality

The likelihood of debt payment is highly dependent on the degree of the issuer's indebtedness and loss absorption capacity in terms of equity capital. Also notable is that a financial institution might see a significant loss of financial grounds as a result of changes in value of the assets under its possession.

#### C) Liquidity Positions

The likelihood of debt payment is highly dependent on the adequacy of the issuer's cash and other sources of repayment (liquidity positions).



- D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

  The likelihood of debt payment is affected one way or the other by the issuer's related parties such as parent company, subsidiary, guarantor, and the government of the issuer's business domicile, etc. by their own conditions and/ or position of support/ assistance for the issuer.
- E) Order of Seniority in Debt Payment

  The likelihood of debt payment can be different between given debts of the same issuer. The
  likelihood of debt payment for an individual debt is dependent on the issuer's discretion, and/ or its
  rank relative to other debts of the same issuer in the order of seniority in principal/ interest payment
  which is determined by design as financial product or by laws, etc.

#### A) Business Bases

The credit rating is subject to alteration if there is improvement or deterioration of the issuer's business bases, since its revenue, etc. may improve or deteriorate by the change in its business management policies, clients' preferences, competitive situation, or a technological innovation. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the business bases is large.

#### B) Financial Grounds and Asset Quality

The credit rating is subject to alteration if the issuer increases/ decreases its debt/ capital or vice versa and thereby makes its individual debt payment liability less or more bearable and its loss absorption capacity into the future decreased or increased. Also, the changes in the quality of asset under the issuer's holding may affect the credit rating, since such changes could raise or lower the likelihood of future loss of the issuer's financial grounds. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change in the financial grounds and/ or asset quality is large.

#### C) Liquidity Positions

The credit rating is subject to alteration if there is a change in the issuer's financial management policy or in the relations with fund procurement sources and the change thereby makes its liquidity positions improve or deteriorate. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is large.



#### D) Related Parties' Status and Stance of Support/ Assistance for the Issuer

The credit rating is subject to alteration if there is a change in the issuer's parent company or subsidiary, guarantor or other provider of credit enhancement, or the government of the issuer's business domicile, or other related parties' own conditions and/ or position of support/ assistance for the issuer, and the change thereby makes its business bases, financial grounds and/ or liquidity positions improve or deteriorate, and/ or making the effectiveness of guarantee and other credit enhancement improve or deteriorate. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large.

#### E) Order of Seniority in Debt Payment and Non-Payment Forgiven by Contract

The credit rating is subject to alteration if there is a change in the rated debt's status in the order of seniority relative to other debts caused by the improvement/ deterioration of the issuer's financial condition. The resultant alteration of the credit rating is usually a notch, with possibility of a few notches if and when the change is large. Also, in case of the financial products for which non-payment of interest/ principal is contractually permissible, the credit rating is subject to alteration if and when the likelihood of such non-payment is projected to increase or decrease. The resultant alteration of the credit rating could be by a notch but often as much as a few notches.

#### F) Rise and Fall in General Economy and Markets

The credit rating is subject to alteration if there is a rise/ fall in the general economy and/ or the markets inducing the issuer's revenues/ expenses to increase/ decrease and vice versa, etc. The resultant alteration of the credit rating is usually by a notch, with possibility of a few notches if and when the change is exceptionally large.

#### G) Various Events

The credit rating is subject to alteration on occurrence of various events, such as change in the issuer's major shareholders, M&A and other organizational change, accident, violation of the law, litigation, legal/ regulatory change, natural disaster, etc., which are unforeseeable at the time when the credit rating is determined, causing a significant change on the issuer's business bases, financial grounds, etc. The resultant alteration of the credit rating could be by a notch but more often than not as much as a few notches.
