## Method of Data Delivery

### ▶ Data Format

- ✓ CSV (Comma-Separated Values)
- ✓ Unique Number (such as ISIN code) on each bond/instrument
- ✓ Common data format adopted by all Japanese CRAs

### ▶ Data Delivery<sup>1/</sup>

- ✓ Every business day (as long as publication is made)
- ✓ Via one of VAN Providers or Information Vendors <sup>2/</sup>
- ✓ Delivery time: Between 3:30 pm and 5:00 pm (JST)

*Historical dataset (optional) can also be purchased separately with e-mail, etc.*

## J-CRIS Contract & Fee

### ▶ Standard Contract (Per company basis)

- ✓ Company's **Internal Use** Only

Annual Fee JPY 2.4 million (excluding tax) /excluding Historical data

Historical data Fee JPY 1 million (excluding tax, paying in a lump sum, Option)

*When an affiliated company and the like use this service, another contract is required.*

### Display License (Option)

- ✓ **External Use** (Display only)

*License to display J-CRIS data to external 3rd parties on your own format.*

*Downloading of J-CRIS data by external 3rd parties is not permitted.*

Annual Fee JPY 6 million (excluding tax)

*For Display License, Standard Contract is also required.*
